What is the purpose of this update?

This document tells you how the Mercer Ethical Leaders Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in shares listed on international share markets managed within a sustainable approach. The fund is managed to specific 'sustainable investment' criteria which aim to avoid investments in certain companies or activities, and encourage investment in companies with strong environmental, social and governance characteristics. This fund has additional exclusions applied as described in our Sustainable Investment Policy and has been certified by the Responsible Investment Association of Australasia (RIAA).

The fund aims to outperform the MSCI World Index with net dividends reinvested (50% hedged to NZD on an aftertax basis) on a rolling five-year basis.

What are the risks of investing? Risk indicator for the Mercer Ethical Leaders Global Shares Fund:

Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$2,448.00 (that is 24.48% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$2,448.00 for the year.


Actual investment mix⁴

Currency management

The fund targets a position of being 69% gross hedged to the New Zealand dollar. The hedges are based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 30 September 2024 was 50.25%.
