
Description of this fund

The Smart Total World ETF is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index. The Index is comprised of large, mid and small cap companies located around the world.

What are the risks of investing?

Risk indicator for the Smart Total World ETF




How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,834 (that is 28.34% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,668 for the year.
