Fund update for the quarter ended 31 December 2023

This fund update was first made publicly available on 12 February 2024.

What is the purpose of this update?

This document tells you how the Smartshares Total World (NZD Hedged) ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index, 100% NZD hedged.

Total value of the fund: \$89,230,610

The date the fund started: 15 July 2020

What are the risks of investing?

Risk indicator for the Smartshares Total World (NZD Hedged) ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating. 

How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1923 (that is 19.23% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1816 for the year.

Currency hedging

As at 29 December 2023 the fund's exposure to assets denominated in foreign currencies was 96.04%, of which 96.72% was hedged. This means the fund's unhedged foreign currency exposure was 3.15% of the net asset value of the fund. Notes

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year and 7 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
