#### What is the purpose of this update?

#### What are the risks of investing?

Risk indicator for the Global Fund:


#### How has the fund performed?

#### Annual return graph



This shows the return after fund charges and tax for the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2023.

#### What fees are investors charged?

Investors in the Global Fund are charged fund charges that include GST. In the year to 31 March 2023 these were:

## Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,871 (that is 18.71% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$1,871 for the year.

#### **Currency hedging**

The benchmark currency hedge ratio for International equities is 50% hedged into NZD. At quarter end the fund was 49.0% hedged into NZD.
