### What is the purpose of this update?


### **Description of this fund**

The Smart NZ Mid Cap ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX MidCap Index. The Index is comprised of companies listed on the NZX that are included in the S&P/NZX 50 Index but are not included in the S&P/NZX 10 Index.

## What are the risks of investing?

#### Risk indicator for the Smart NZ Mid Cap ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




### How has the fund performed?

### What fees are investors charged?

Investors in the Smart NZ Mid Cap ETF are charged fund charges. In the year to 31 March 2025 these were:


### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$597 (that is 5.97% of Tara's initial \$10,000). This gives Tara a total return after tax of \$501 for the year.
