What is the purpose of this update?

This document tells you how the InvestNow Mint Australasian Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide investors with superior returns with lower risk than the S&P/NZX 50 Gross Index after fees and expenses over the medium to long-term.

Strategy: provides exposure to an actively managed portfolio that typically invests in New Zealand and Australian listed equities.

What are the risks of investing?



How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,380 (that is 13.80% of his initial \$10,000). This gives Anthony a total return after tax of \$1,332 for the period.



What does the fund invest in? This shows the types of assets that the fund invests in.


Actual Investment Mix

Notes
