Description of this fund


The Smart Japan ESG ETF is designed to track the return (before tax, fees and other expenses) of the MSCI Japan ESG Screened Index.

The Index is comprised of Japanese companies screened for exposure to controversial weapons, civilian firearms, tobacco, thermal coal and oil sands. The Index excludes companies that fail to comply with the United Nations Global Compact Principles. For more information, please refer to the <u>Smart Responsible Investment Policy</u>.




How has the fund performed?

What fees are investors charged?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,030 (that is 20.30% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,874 for the year.

Notes
