What is the purpose of this update?

What are the risks of investing?


How has the fund performed?

Annual return graph

What fees are investors charged?

Investors in the Trans Tasman Equity Trust are charged fund charges that include GST. In the year to 31 March 2025 these were:

Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$159 (that is 1.59% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$159 for the year.



What does the fund invest in?


Actual investment mix

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 72.9% hedged into NZD.
