Total estimated costs of Offer and issue

BNZ estimates that the total costs it will incur in connection with the Offer and issue of the PPS will be NZ\$4.59 million (excluding GST). This includes syndicate fees, legal fees, registry, distribution and promotion expenses and any other fees or expenses that BNZ expects to incur in connection with the Offer.

The amount of the fees payable by BNZ in connection with the Offer in respect of syndicate fees and NZX quotation fees (together the "**Offer Fees**") will vary depending on the amount raised under the Offer. BNZ estimates that the total of the Offer Fees it will pay will be NZ\$4.00 million (excluding GST) (assuming \$250 million of PPS are issued under the Offer). Most of the Offer Fees will be payable to the Arranger to be distributed as applicable to the Joint Lead Managers and other intermediaries. These fees are payable for providing advice and assistance to BNZ in connection with the arranging, managing and marketing of the Offer and the distribution of the PPS. The Offer Fees also include payments to NZX for the quotation of the PPS.
