# Sustainable Conservative fund Mercer KiwiSaver scheme

#### Quarter ending 30 September 2024

This fund update was first made publicly available on: 29 October 2024.

#### What is the purpose of this update?

This document tells you how the Sustainable Conservative fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

This information is not audited and may be updated.

#### **Description of this fund**

Invests mostly in defensive assets such as fixed interest, with only limited investment in growth assets such as shares. May be suitable for investors who want to achieve slightly higher returns than those expected from investing solely in the Cash fund. Investors need to be comfortable with the possibility of some fluctuations in returns. This fund is managed with reference to environmental, social and governance (ESG) factors and is certified by the Responsible Investment Association of Australasia.

## What are the risks of investing?

# Risk indicator for the Sustainable Conservative fund: <sup>†</sup>



## What fees are investors charged?

#### Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$959.00 (that is 9.59% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$959.00 for the year.


#### Actual investment mix

The top 10 investments make up 17.54% of the fund.

#### **Currency hedging**

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for global shares is managed between 0% and 100% on a net of tax basis and may change over time depending on Mercer's view of the relative strength (or weakness) of the New Zealand dollar. Other global asset classes (Global Fixed Interest) target a 100% net of tax hedge to the New Zealand dollar. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 30 September 2024 was 85.05%.
