## What is the purpose of this update?

This document tells you how GlidePath Age 55 has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this Fund**

GlidePath age 55 is a representation of the GlidePath life cycle. This investment option invests 11% in the Growth Fund and 89% in the Balanced Fund.


Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$302 (that is 3.02% of her initial \$10,000). This gives Jen a total return after tax of \$302 for the year.
