What is the purpose of this update?


Description of this fund

The fund invests in shares listed on share markets in emerging economies. The portfolio is managed using a single manager. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Gross Return² above the MSCI Emerging Market ex Tobacco Index with net dividends reinvested (in NZD) on a rolling three to five-year basis.

What are the risks of investing?

Risk indicator for the Mercer Emerging Markets Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$2,579.00 (that is 25.79% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$2,579.00 for the year.

What does the fund invest in?


Actual investment mix

Notes

1. The Manager has resolved to wind up the Mercer Emerging Markets Shares Fund. The fund was closed to new investors on 18 December 2025 and closed to all investment on 30 January 2026. The wind up will commence on 13 February 2026. This will involve liquidating the fund's investments and distributing the proceeds to remaining investors in proportion to their unit holdings. Existing investors received communications on 18 December 2025 containing further information about this closure. 2. Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.
3. These returns are for the periods ending 31 December 2025.
4. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
5. GST is currently charged at 15% on 10% of the management fee in accordance with the non-binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.
6. The Top 10 investments have been calculated excluding operational cash and derivatives.
