
Description of this fund

The Smart US Large Growth ETF is designed to track the return (before tax, fees and other expenses) of the CRSP US Large Cap Growth Index. The Index is comprised of large US growth companies.

What are the risks of investing?

Risk indicator for the Smart US Large Growth ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,249 (that is 12.49% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,104 for the year.
