Fund update for the quarter ending 30 June 2025

This fund update was first made publicly available on 25 July 2025.

What is the purpose of this update?

This document tells you how the Sharesies US500 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the **Financial Markets Conduct Act 2013**. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in a US exchange traded fund (ETF) that provides exposure to large US companies. Aims to achieve returns similar to its benchmark, the Morningstar US Target Exposure TR NZD Index.

What are the risks of investing?

Risk indicator for the Sharesies US500 Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katy had \$10,000 in the fund on 20 March 2025 (the date the fund started) and did not make any further contributions. At the end of the period to 30 June 2025, Katy received a return after fund charges were deducted of \$556.27 (that is 5.56% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$525.51 for the period from 20 March 2025 to 30 June 2025.

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
