

## Smart Australian Resources ETF

### Fund update for the quarter ended 31 December 2024

### What is the purpose of this update?

This document tells you how the Smart Australian Resources ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. 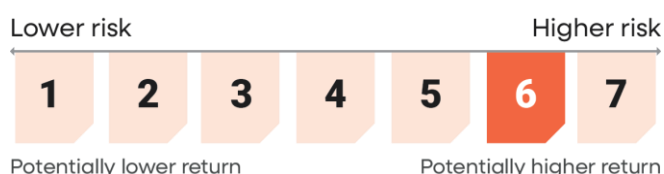
### Description of this fund

The Smart Australian Resources ETF is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 Resources Index. The Index is comprised of companies from the S&P/ASX 200 Index where the company is classified as belonging to the energy sector or the metals and mining industry.

### What are the risks of investing?

#### Risk indicator for the Smart Australian Resources ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

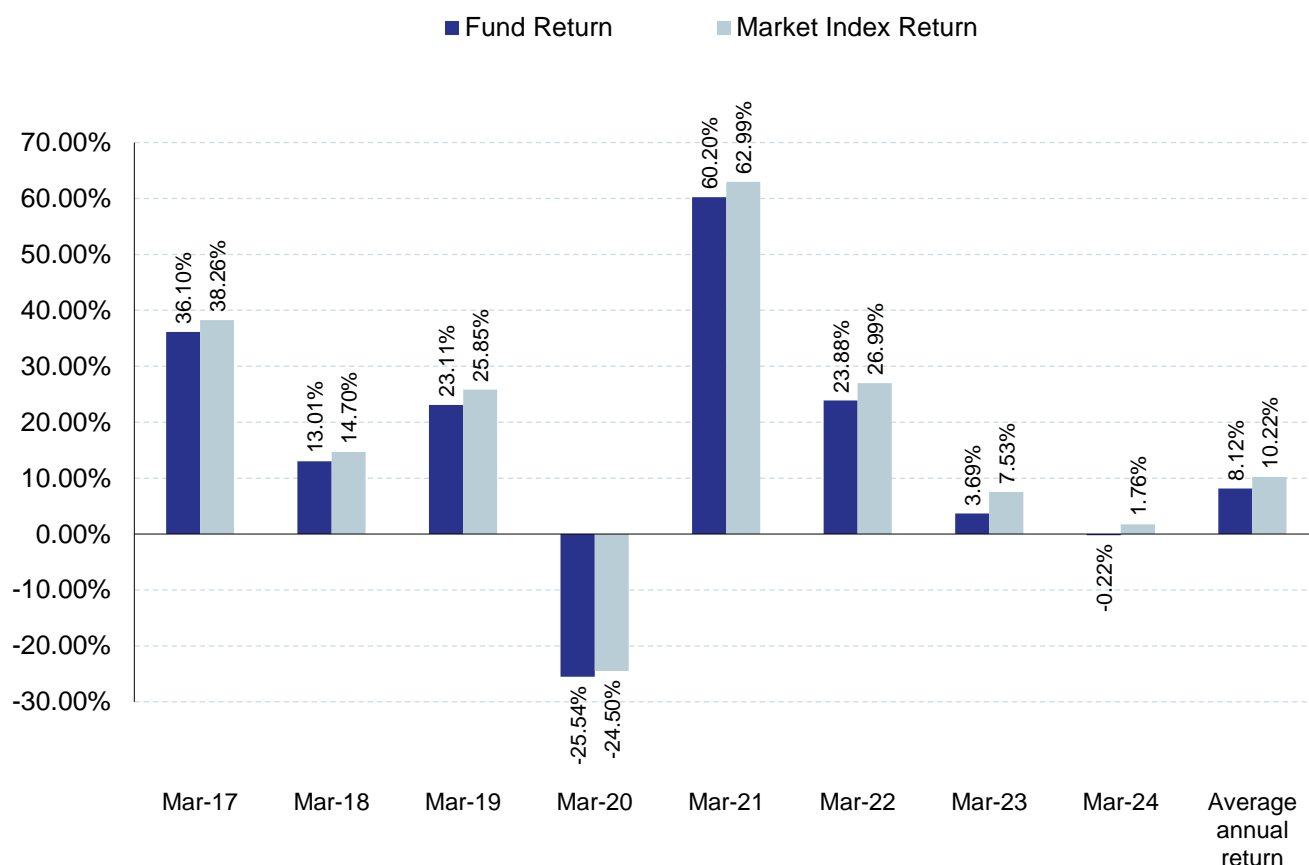

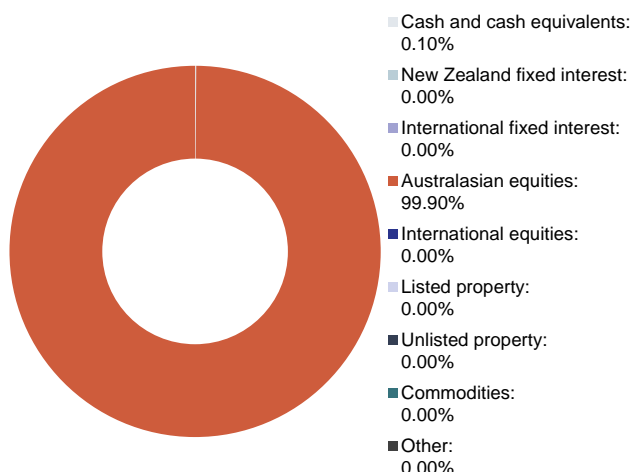
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of -\$1,375 (that is -13.75% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$1,481 for the year.
