What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ANZ New Zealand Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Conservative Fund invests mainly in income assets (cash and cash equivalents and fixed interest), with a smaller exposure to growth assets (equities, listed property and listed infrastructure). The fund may also invest in alternative assets.

The Conservative Fund aims to achieve (after the fund charge and before tax) over the long term low relatively stable returns, allowing for small ups and downs in value.

What are the risks of investing?

Risk indicator for the Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

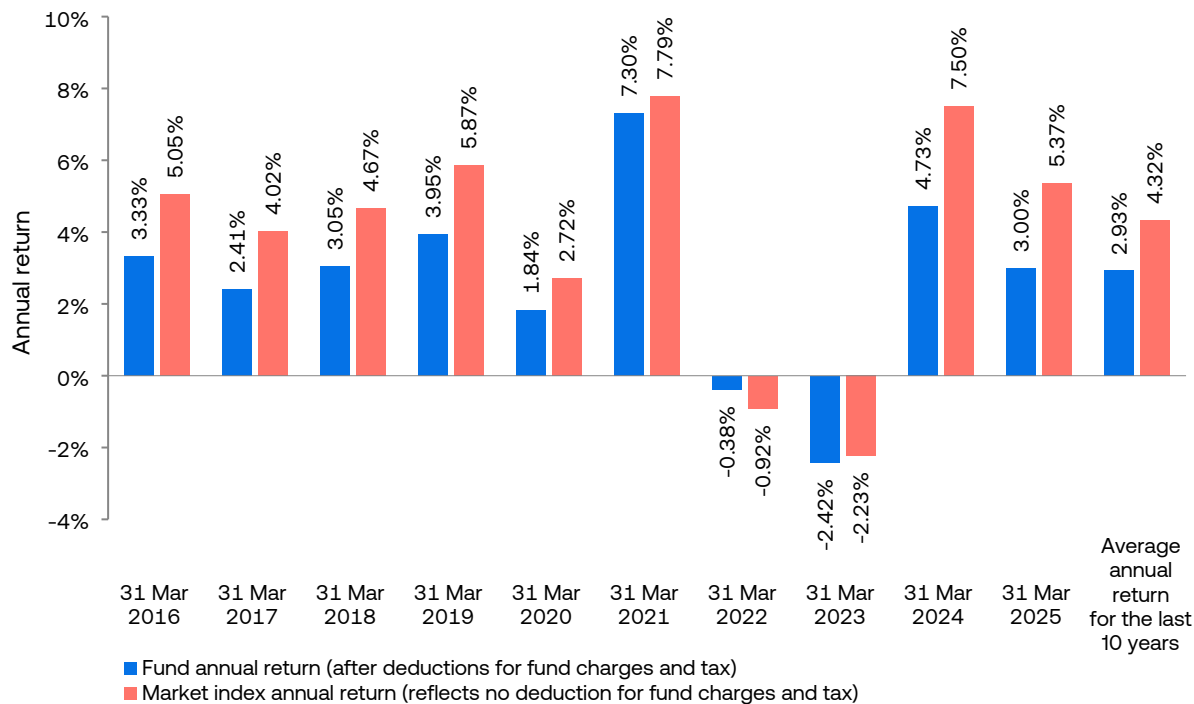
How has the fund performed?

The market index annual return is calculated using the target investment mix and the indices of each asset class. The composition of the market index for this fund changed effective 23 October 2025 due to a change in the target investment mix and the underlying market indices for the cash and cash equivalents, New Zealand fixed interest and international fixed interest asset classes. These changes were made to more accurately reflect the fund's investment strategy.

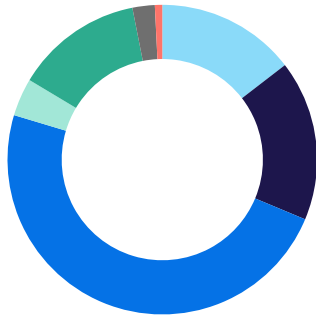
Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$439 (that is 4.39% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$439 for the year.

Actual investment mix²

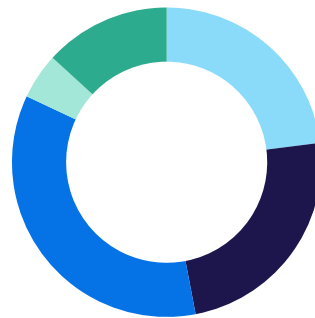
This shows the types of assets that the fund invests in.
