What is the purpose of this update?

This document tells you how the Smart NZ Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Smart NZ Bond ETF is designed to provide a return (before tax, fees and other expenses) that outperforms the S&P/NZX A-Grade Corporate Bond Total Return Index over rolling three-year periods.

What are the risks of investing?

Risk indicator for the Smart NZ Bond ETF

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.




Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$692 (that is 6.92% of Tara's initial \$10,000). This gives Tara a total return after tax of \$494 for the year.
