#### What is the purpose of this update?

This document tells you how the Trans Tasman Equity Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. #### What are the risks of investing?

Risk indicator for the Trans Tasman Equity Trust:


#### How has the fund performed?

#### Annual return graph



This shows the return after fund charges and tax for the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2024.

#### What fees are investors charged?

Investors in the Trans Tasman Equity Trust are charged fund charges that include GST. In the year to 31 March 2023 these were:

# Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,618 (that is 16.18% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$1,618 for the year.



#### What does the fund invest in?

#### **Actual investment mix**

This shows the types of assets that the fund invests in.



#### **Target investment mix**

This shows the mix of assets that the fund generally intends to invest in.



#### **Currency hedging**

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 73.2% hedged into NZD.
