What is the purpose of this update?

This document tells you how the New Zealand Fixed Income Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2025.

What fees are investors charged?

Investors in the New Zealand Fixed Income Trust are charged fund charges that include GST. In the year to 31 March 2025 these were:

Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$517 (that is 5.17% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$517 for the year.
