### What is the purpose of this update?

This document tells you how the International Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this Fund

The fund focuses on growth of your investment over the long term by investing in quality international companies which can consistently produce increasing earnings.

### What are the risks of investing?

Risk indicator for the International Growth Fund:



### How has the fund performed?

## Annual return graph

## What fees are investors charged?

Investors in the International Growth Fund are charged fund charges that include GST. In the year to 31 March 2025 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.



### Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie incurred a loss after fund charges were deducted of -\$107 (that is -1.07% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total loss after tax of -\$107 for the year.

### Actual investment mix


This shows the types of assets that the fund invests in.

### Currency hedging

The benchmark currency hedge ratio for International equities is 50% hedged into NZD. At quarter end the fund was 49.3% hedged into NZD.

- <sup>2</sup> The negative performance-based fee as at 31 March 2025 is a result of the actual performance fee charged to the fund at 30 June 2024 being lower than the fee accrued to 31 March 2024. Because the performance fee period runs from 1 July to 30 June each year and the calculation period for fees disclosed in the fund update runs from 1 April to 31 March each year, the actual amount payable at the end of the current performance period may be greater or less than the performance fees accrued at 31 March and a negative performance fee expense at 31 March is possible. The performance-based fee accrual is calculated on a daily basis. See the product disclosure statement for more information about the basis on which performance fees are charged.
