What is the purpose of this update?

This document tells you how the Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ASB Group Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

To provide moderate to high total returns allowing for moderate to high movements of value up and down. The number of years with negative returns are generally expected to be higher than the Moderate Fund but lower than the Growth Fund in the ASB Investment Funds. We manage asset allocation and currency hedging over the medium to long term relative to the target investment mix. We focus on cost effective management. The Balanced Fund invests in income and growth assets with a target investment mix of 42% income assets and 58% growth assets.

What are the risks of investing?

Risk indicator for Balanced Fund




Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$571.00 (that is 5.71% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$571.00 for the year.

Currency hedging

As at 31 March 2025 the fund's exposure to assets denominated in foreign currencies was 63%, of which 61% was hedged. This means the fund's unhedged foreign currency exposure was 25% of the net asset value of the fund.
