What is the purpose of this update?

This document tells you how the BondPlus Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to provide stable returns over the long term by investing in international fixed interest assets.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$158 (that is 1.58% of her initial \$10,000). Sarah did not pay other charges. This gives Sarah a total return after tax of \$158 for the year.



What does the fund invest in?

Currency hedging

The benchmark currency hedge ratio for International fixed interest securities is 100% hedged into NZD. At quarter end the fund was 100.1% hedged into NZD.
