## What is the purpose of this update?

This document tells you how the Smartshares US Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in US shares and is designed to track the return (before tax, fees and other expenses) of the CRSP US Mid Cap Index.

Total value of the fund: \$81,304,896

## What are the risks of investing?


## How has the fund performed?

## What fees are investors charged?


## **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1527 (that is 15.27% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1380 for the year.
