

# Fund update

## Mercer NZ Shares Passive Fund Mercer Investment Funds

### What is the purpose of this update?

This document tells you how the Mercer NZ Shares Passive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) 
### Description of this fund

The fund is a passively managed New Zealand shares portfolio that is designed to track the return of the S&P/NZX 50 Index. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a return that closely matches the return of the S&P/NZX 50 Index (on a gross basis and including imputation credits).

### What are the risks of investing?

#### Risk indicator for the Mercer NZ Shares Passive Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## What fees are investors charged?

\*Based on an increase in the 'Other management and administration charges' to an estimated 0.35% from 1 August 2025, the Manager estimates that the total fund charges will increase to 0.63% of the net asset value for the next scheme year.


### Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$233.00 (that is 2.33% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$233.00 for the year.


### Actual investment mix
