### What is the purpose of this update?

This document tells you how the Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to provide a balance between stability of returns and growing your investment over the long term by investing in a mix of income and growth assets.

# What are the risks of investing?

Risk indicator for the Balanced Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# How has the fund performed?

### What fees are investors charged?

Investors in the Balanced Fund are charged fund charges. In the year to 31 March 2024 these were:


# Example of how this applies to an investor

Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$1,108 (that is 11.08% of her initial \$10,000). This gives Jen a total return after tax of \$1,108 for the year.

#### **Actual investment mix**


This shows the types of assets that the fund invests in.
