# External fund manager descriptions

The descriptions of the external fund managers of our underlying single-asset-class funds are as follows:

Fund manager	Description
BlackRock Investment Management	BlackRock Investment Management (Australia) Limited (BlackRock) manages a portfolio of international developed market equities. BlackRock evaluates companies across style factor characteristics such as quality, value, momentum, low volatility and size to form an expected return, then invests in a selection of those companies with the best combined expected return.
Lazard Asset Management	Lazard Asset Management (Lazard) manages a portfolio of emerging market equities. Lazard uses a quantitative, research-driven approach to bottom-up stock selection, aiming to produce consistent returns in most market environments. Lazard seeks to build core portfolios avoiding biases to style, sector, geography or company size.
LSV Asset Management	LSV Asset Management (LSV) manages a portfolio of international developed market equities. LSV aims to invest in out-of-favour or undervalued stocks that have the potential for near-term appreciation.
Maple-Brown Abbott	Maple-Brown Abbott (MBA) manages a portfolio of global listed infrastructure securities. MBA targets infrastructure assets that they believe have a high degree of inflation protection, low cash flow volatility and strong corporate governance.
Northern Trust Investments, Inc. (international fixed interest)	Northern Trust Investments, Inc. (Northern Trust) manages portfolios of global fixed interest assets issued by governments and global corporates. Government bonds are managed to follow a global treasury index while global corporate bonds are selected based on quality and value considerations.
Northern Trust Investments, Inc. (international equities)	Northern Trust manages a portfolio of international developed market equities managed to deliver international developed market equity index returns.
Pendal Group	Pendal Group (Pendal) manages a portfolio of Australian equities. Pendal's investment approach focuses on anticipating the level and quality of company earnings, considering stock specific factors including industry structure, cyclical trends and capital allocation.

RBC BlueBay	RBC BlueBay manages a high-conviction portfolio of emerging market equities with a quality growth focus. RBC BlueBay uses a bottom-up, fundamental research approach and aims to invest in companies with quality management, superior franchises and durable business practices that incorporates ESG factors.
Resolution Capital Limited	Resolution Capital Limited (Resolution Capital) manages a select and diverse group of international developed market listed property assets that they believe are capable of generating superior risk adjusted returns for investors.
