This document gives you important information about this investment to help you decide whether you want to invest. This document replaces the product disclosure statement dated 14 May 2024.

01. Key information summary

What is this?

This is a managed investment scheme. Your money will be pooled with other investors' money and invested in various investments. Sharesies Investment Management Limited (Sharesies Investments, SIML, we, us, our) will invest your money and charge you a fee for its services.

The returns you receive are dependent on the investment decisions of SIML and the performance of the investments. The value of those investments may go up or down. The types of investments and the fees you will be charged are described in this document.

WARNING

The law normally requires people who offer financial products to give certain specified information to investors before they invest. This requires those offering financial products to have disclosed information that is important for investors to make an informed decision.

The usual disclosure rules do not apply to parts of this offer because Sharesies Investments has an exemption for offers of investments in self select schemes. With a self select scheme, you choose the investments you want in your investment portfolio from a list of investment options provided by Sharesies Investments.

As a result of the exemption, you may not have information that allows you to easily understand the overall risks and fees that apply to your investment portfolio. You will also not be able to easily compare an investment in the self select scheme with other similar managed funds.

Investments in self select schemes will not be suitable for all retail investors. We recommend that you seek independent financial advice before committing yourself. A financial adviser can help you understand your risk profile and assist you to select investments that are suitable for you.

We suggest you ask questions, read all documents carefully, and seek independent financial advice before committing yourself.

What will your money be invested in?

The Sharesies KiwiSaver Scheme (the Scheme) offers 7 Base Funds for you to invest in plus the Self Select Fund. These investment options are summarised below. More information about the investment target and strategy for each investment option is provided at section 3 "Description of your investment options".

Who manages the Sharesies KiwiSaver Scheme?

Sharesies Investment Management Limited is the manager of the Scheme. Refer to **section 7 "Who is involved"** for more information.

How can you get your money out?

Generally, you can withdraw your investment when you reach the age to qualify for New Zealand superannuation (currently age 65).

You can transfer your investment to another KiwiSaver scheme at any time.

In certain circumstances, you may be able to make an early withdrawal. These circumstances include the purchase of a first home, financial hardship and serious illness.

How will your investment be taxed?

The Scheme is a portfolio investment entity (PIE). The amount of tax you pay in respect of a PIE is based on your prescribed investor rate (PIR). To determine your PIR, go to ird.govt.nz/pir. See section 6 "What taxes will you pay?" on page 11 for more information.

Where can you find more key information?

Sharesies Investment Management Limited is required to publish quarterly updates for each fund. The updates show the returns, and the total fees actually charged to investors, during the previous year. The latest fund updates are available at sharesies.co.nz/kiwisaver. The manager will also give you copies of those documents on request.

The quarterly fund updates will be provided in fund updates for the Base Funds and in personalised quarterly reports for the Self Select Fund.

02. How does this investment work?

KiwiSaver is a long-term savings initiative designed to encourage you to save for your retirement. The key benefits of the Sharesies KiwiSaver Scheme are:

- Provides you with flexibility to combine a range of investment options on the Sharesies platform.
- · A range of managed fund options.
- Self selecting your investment portfolio. This allows you to choose a broad range of investments that suit your risk profile and investment objectives.

There is no Crown guarantee in respect of any KiwiSaver scheme or investment product of a KiwiSaver scheme.

Structure of the Scheme

The Scheme is a unit trust governed by a governing document between Sharesies Investments, as manager, and Trustees Executors Limited (**TEL**), as the Scheme's Supervisor. The assets of each fund within the Scheme are held on trust by Apex Investment Administration (NZ) Limited (**Apex**) as custodian . Apex may appoint a nominee / sub-custodian.

The Scheme is a "defined contribution scheme". This means the benefits you receive depend on the contributions paid to your account, investment gains and losses, and any money deducted from your account (e.g., for fees and taxes).

Your account is invested in whichever funds you select and its value varies in accordance with the returns achieved by the funds chosen. The number of units you have, when multiplied by the unit price, represents the value of your KiwiSaver savings in a fund, excluding unpaid tax or tax rebates.

The savings in your KiwiSaver account grow when your fund's unit price increases. This will happen when the assets that the fund invests in increase in value. Your savings can also go down when the assets the fund invests in decrease in value.

These units do not give you ownership rights in respect of any fund assets, but they do give you rights from those assets, including returns. Each fund and investment option is treated as a separate and distinct portfolio. This means that the assets of one fund cannot be used to cover the liabilities of another fund.

In our Scheme, you can simultaneously invest in managed funds and in our range of self select investment options.

Joining the Scheme

You can join the Scheme if you:

- · are living or normally living in New Zealand; and
- are a New Zealand citizen, or entitled to live in New Zealand permanently.

We can decide not to accept your application to join. If that happens, we will let you know.

You can also join if you're a New Zealand government employee who is working overseas on New Zealand terms and conditions (provided that KiwiSaver membership is lawful in your jurisdiction).

If you are already a KiwiSaver member, you can transfer your savings to the Scheme.

To join the Scheme you must first become a Sharesies customer. You can join or transfer to the Scheme by applying online at sharesies.co.nz.

When you apply to join the Scheme, you provide us with instructions to invest your KiwiSaver contributions. These instructions are referred to as your Investment Plan. You can also update your Investment Plan at any time.

See **section 10 "How to apply"** for more information on joining the Scheme.

Making investments

If you're employed, KiwiSaver contributions are deducted from your pre-tax (gross) salary or wages at a rate of 3%, 4%, 6%, 8% or 10%. If you do not select a rate your default rate will be 3%. If you are contributing to KiwiSaver, you may also be entitled to an employer contribution of 3% of your pre-tax salary or wages. Tax is deducted from employer contributions.

Any member can also make additional voluntary contributions by regular or lump sum payments.

If you're over 18 and below the superannuation age (currently 65), the Government will (if you're eligible) contribute 50 cents for every dollar you contribute, up to a maximum Government contribution of \$521.43 each year (1 July to 30 June). This is paid directly to your KiwiSaver account around late July each year.

You can change your contribution rate or have a 'savings suspension', subject to some restrictions.

You may also be able to transfer savings from an existing New Zealand or overseas superannuation scheme. To transfer from an Australian complying superannuation fund, you will need to have permanently emigrated to New Zealand.

Withdrawing your investments

You are generally not eligible to withdraw your investment in the Scheme until you reach the New Zealand superannuation qualification age (currently 65). Once you are able to withdraw your investment, you may withdraw your investment by making regular or lump sum withdrawals or by withdrawing the full amount. You may also continue to make contributions to the Scheme.

Early withdrawals are permitted in limited circumstances. The main types of early withdrawals available and what you can withdraw are set out below.

You can also transfer your investment to another KiwiSaver scheme at any time. You can only be a member of one KiwiSaver scheme at a time.

If you die, we will pay your investment to your personal representatives (the executors or administrators of your estate) or otherwise in accordance with law.

Withdrawals may also be required by law (for example, if a court orders the release of money from your account).

Under the governing documents, in limited circumstances we can suspend the ability to make withdrawals.

How to switch between funds

You may update your Investment Plan at any time through our platform. When you update your Investment Plan we will ensure your instructions are within the Guardrails (described in **section 3**) set for investing in the Scheme. Any updates to your Investment Plan will apply to all future contributions.

Changing your Investment Plan may result in changes to the fees you are charged including transaction fees for the Self Select Fund. Refer to **section 5** "What are the fees?" for more information.

Responsible investment

Responsible investment, including environmental, social, and governance considerations, is not taken into account in the investment policies and procedures of the Scheme as at the date of this product disclosure statement. However, some underlying funds available as investment options have responsible/ethical/sustainable investment policies and procedures. Our 'Guardrails'

To encourage Scheme members to grow diversified portfolios the Self Select Fund includes investment limits or 'Guardrails'. Our Guardrail settings are:

The Guardrails are built directly into our systems and are the primary control to ensure that investment limits are effective.

You provide us with instructions to invest your KiwiSaver contributions. These instructions are referred to as your Investment Plan. When you establish your Investment Plan we will ensure your instructions are within the Guardrails.

The Guardrail Policy records the current Guardrail settings, details the monitoring and corrective actions we will take relating to guardrails and describes the processes for changing Guardrail settings.

Where a single Self Select Fund investment option makes up more than 10% of a member's KiwiSaver balance for more than 90 days or a single Self Select Fund options makes up more than 15% of a member's KiwiSaver balance, we will take corrective action and temporarily remove that option from the Investment Plan until the balance is back within the 10% threshold.



The Scheme's SIPO is established by Sharesies Investment Management Limited in consultation with the Supervisor. It contains the investment philosophy, strategies, and objectives for each fund. We can make changes to the SIPO, from time to time without notifiying you, if we decide a change is appropriate. Before making changes to the SIPO, we will consider if the changes are in the best interests of Members and consult with the Supervisor. Any changes to the SIPO require Sharesies Investments Board approval, as well as written approval of the Supervisor. Changes will also be communicated no later than the next quarterly fund update or personalised quarterly report. 
Example KiwiSaver investment plan



04. What are the risks of investing?

Understanding the risk indicator

Managed funds in New Zealand must have a standard risk indicator. The risk indicator is designed to help investors understand the uncertainties both for loss and growth that may affect their investment. You can compare funds using the risk indicator.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

To help you clarify your own attitude to risk, you can seek financial advice or work out your risk profile at <u>sorted.org.nz/tools/investor-kickstarter</u>.

Note that even the lowest category does not mean a risk-free investment, and there are other risks (described under the heading "Other specific risks") that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the 5 years to 31 March 2025. While risk indicators are usually relatively stable, they do shift from time to time. You can see the most recent risk indicator in the latest fund update for this fund.

General investment risks

Some of the things that may cause a fund's value to move up and down, which affect the risk indicator, are:

Market risk - Fund returns are directly affected by the overall performance of the financial markets. Therefore the value of investments may go up and down in response to changes in market conditions.

Credit risk - This is the risk of any investment in the portfolio becoming insolvent and being placed in receivership, liquidation or statutory management, or being otherwise unable to meet its financial obligations. If an investment becomes insolvent, it may be Side-Pocketed. Asset allocation risk - This is the risk that the fund has a higher allocation to an asset class that does not perform as well as expected, or has a lower allocation to an asset class that performs better than expected.

Currency risk - The risk that changes in exchange rates cause the value of an international investment to fall.

Benchmark trading risk - The risk that the underlying investments that are passively managed generate returns that differ from the benchmark index, due to reasons such as the choice of index replication methodology, cash drag, transactional costs, or in the case of ETFs, underlying investments trading at a premium or discount to its asset value.

Interest rate risk - Interest rate risk is the possibility that an investment held will decline in value as a direct result of changes in interest rates.

Liquidity risk - This is the risk that the fund cannot easily sell its investments or can only sell at a much lower price than in normal market conditions. This may affect the value of the fund's assets and applies to both listed and any unlisted investments of the funds. If an investment becomes illiquid, it may be Side-Pocketed. For more information on side-pocketing see the OMI and Side Pocketing Policy, available at sharesies.co.nz/kiwisaver and on the Disclose Register at disclose-register.companiesoffice.govt.nz.

Counterparty risk - This is the risk that the financial strength of a party to a contract with the fund fails to perform its obligations or its financial strength worsens. If such a party (which includes underlying fund managers, banks and brokers) defaults on its obligations to the fund or becomes insolvent, then the value of the fund will be affected.

Other specific risks

There are other factors that may impact members' returns that are not reflected in the risk indicator.

Fund selection risk - There is a risk relating to the selection of the underlying fund managers who are responsible for managing the underlying funds that the Scheme's funds invest into. We mitigate this risk by having an appropriate manager selection and monitoring process, However, there is the risk an underlying fund manager underperforms compared to other fund managers.

Investment selection risk - There is a Scheme specific risk that, in constructing a portfolio, you have an inappropriate income/growth split or that you fail to monitor and manage the portfolio in line with your investment objectives. There is also a risk that you may select an investment option that underperforms the market or other investments. We mitigate this risk by providing you with a risk indicator score in respect of your investment plan. However, it remains the decision of the member as to whether they wish to diversify or rebalance their portfolio and we will only act on member instructions.

Concentration risk - There is a Scheme specific risk that you may over-invest in a particular security, sector, industry, region or product. A lack of adequate diversification could leave your portfolio vulnerable. We mitigate this risk by providing you with a risk indicator score in respect of your investment plan. However, it remains the decision of the member as to whether they wish to diversify or rebalance their portfolio and we will only act on member instructions.

Integrated financial product risk - An integrated financial product is one that incorporates non-financial factors alongside financial factors when making investment decisions. The underlying funds' responsible/ethical/ sustainable policies may limit the number of investment opportunities available. As a result, at times, the underlying funds may produce more modest gains than funds which do not take non-financial factors into account when making investment decisions.

There is also a risk that the underlying funds may not achieve their sustainability goals and may therefore not deliver the intended outcomes.

05. What are the fees?

You will be charged fees for investing in the Sharesies KiwiSaver Scheme. Fees are deducted from your investment and will reduce your returns. If Sharesies Investments invests in other funds, those funds may also charge fees. The fees you pay will be charged in two ways:

Regular charges (for example, annual fund charges). Small differences in these fees can have a big impact on your investment over the long term.

One-off fees (for example transaction fees and currency exchange fees).

This is paid to us for the operation of the Self Select Fund and is included in the Annual fund charges. There is no Administration fee for the Base Funds as in some cases we are remunerated by the underlying fund manager.

¹Self select investment options that invest in underlying funds may also have fees (including performance-based fees), and expenses which are charged by the manager of that fund. These fees and expenses will be reflected in the fund's unit price and may therefore indirectly affect your returns. The fund charges represent our best estimates of the fees and expenses that will be charged to each fund. These

have been estimated using information provided by the underlying fund managers and by reference to each underlying fund's disclosure documents.

The fund charges are deducted from and reflected in the value of each fund. The fund charges include all normal day-to-day fund costs and expenses including the fees and charges charged by the Supervisor, custodian and other service providers. They also include the fees and costs charged by any other funds we invest in.

Sharesies Investments may be remunerated by the underlying fund managers.

Transaction fees

When you buy or sell units in the Self Select Fund, you will be charged a transaction fee. This fee will be deducted from the buy or sell amount and is paid to us.

There is no GST charged on transaction fees.

Currency exchange fees

When you buy or sell units in the US500 Fund, you will be charged a currency exchange fee. This fee will be deducted from the buy or sell amount and is paid to us.

There is no GST charged on currency exchange fees.

The fees can be changed

The underlying fund fees are set by the underlying fund managers and not by us. This means they can change at any time and without prior notice to you. Under the Scheme's Governing Document, the fees charged by the Scheme can be changed and we will give 30 days prior written notice to the Supervisor and affected members.

We must publish a fund update for each fund showing the fees actually charged during the most recent year. Fund updates, including past updates, are available at sharesies.co.nz/kiwisaver. Information on the fees actually charged during the most recent year will also be available in the personalised quarterly report.

Example of how fees apply to an investor

Katy invests \$10,000 in a mix of one Base Fund (\$7,000) and investment options within the Self Select Fund (\$3,000).

They are charged a Transaction fee when the funds are invested in the Self Select Fund of \$30 (1% of \$3,000).

This brings the starting value of their investment to \$9,970.

They are charged an Administration fee on the Self Select Fund, which works out to \$4.50 (0.15% of \$3,000).

They are charged an Annual fund charge on the Base Fund, which works out to \$92.40 (1.32% of \$7,000).

These fees might be more or less if their account balance has increased or decreased over the year and are dependent on the type of investment they have selected.

Estimated total fees for the year

Transaction fees (Self Select Fund)*: \$30 Administration fee (Self Select Fund): \$4.50 Annual fund charge (Base Funds): \$92.40

*These fees will change depending on how often Katy buys or sells units in the Self Select Fund. When you buy or sell units in the Self Select Fund, any transaction fees applicable at that time will be a cost to you. Katy may also be charged currency exchange fees if they buy or sell units in other currencies.

If Katy's investment options invest in funds/ETFs, Katy may be subject to underlying fund fees and expenses. Information on the underlying fund fees and expenses can be found in the IOS. This is available on our website at sharesies.co.nz/kiwisaver and on the Disclose Register at disclose-register.companiesoffice.govt.nz.

06. What taxes will you pay?

The Scheme is a portfolio investment entity (**PIE**). The amount of tax you pay is based on your prescribed investor rate (**PIR**). To determine your PIR, go to <u>ird.govt.nz/pir</u>. If you are unsure of your PIR, we recommend you seek professional advice or contact the Inland Revenue Department.

It is your responsibility to tell us your PIR when you invest or if your PIR changes. If you do not tell us, a default rate may be applied. If the rate applied to your PIE income is lower than your correct PIR, you will be required to pay any tax

shortfall as part of the income tax year-end process. If the rate applied to your PIE income is higher than your PIR, any tax over-withheld will be used to reduce any income tax liability you may have for the tax year and any remaining amount will be refunded to you.
