What is the purpose of this update?

What are the risks of investing?


How has the fund performed?

What fees are investors charged?

Investors in the Growth Fund are charged fund charges that include GST. In the year to 31 March 2023 these were:

Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$1,703 (that is 17.03% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$1,703 for the year.





This shows the types of assets that the fund invests in.


