

# Octagon Investment Funds Fund Update as at 31 March 2025

This fund update was first made publicly available on 1 May 2025.

## What is the purpose of this update?

This document tells you how the Listed Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Listed Property Fund mostly invests in listed financial products issued by entities whose principal business involves the owning or managing of property, property-like assets or real assets. It aims to achieve long-term returns (before fees, taxes and other expenses) greater than the S&P/NZX All Real Estate Gross with Imputation Index.

## What are the risks of investing?

Risk indicator for the Listed Property Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




#### Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane incurred a loss after fund charges were deducted but before tax of \$753 (that is -7.53% of her initial \$10,000). This gives Jane a total loss after tax of \$814 for the year.

The top 10 investments make up 88.46% of the fund.

We actively manage the fund's foreign currency exposures. As at 31 March 2025, these exposures represented 4.84% of the value of the fund. After allowing for foreign currency hedges in place, 2.68% of the value of the fund was unhedged and exposed to foreign currency risk.
