#### What is the purpose of this update?

This document tells you how the Property & Infrastructure Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund focuses on growth of your investment over the long term by investing in New Zealand and international property and infrastructure assets.

#### What are the risks of investing?


#### How has the fund performed?

#### What fees are investors charged?

Investors in the Property & Infrastructure Fund are charged fund charges that include GST. In the year to 31 March 2024 these were:

## Example of how this applies to an investor


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$301 (that is 3.01% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$301 for the year.



#### What does the fund invest in?


#### **Actual investment mix**

#### **Currency hedging**

The benchmark currency hedge ratio for Australian and international assets is 70% hedged into NZD. At quarter end the fund was 72.4% hedged into NZD.
