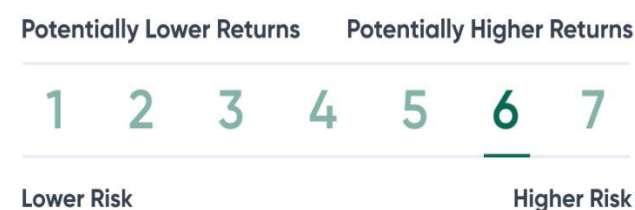
Description of this fund

The Kernel S&P 500 (Unhedged) Fund's investment objective is to provide a return (before tax, fees and expenses) that closely matches the return on the S&P 500 NZD Index.

What are the risks of investing?

Risk indicator for the Kernel S&P 500 (Unhedged) Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. Small differences in fees and charges can have a big impact on your investment over the long term.

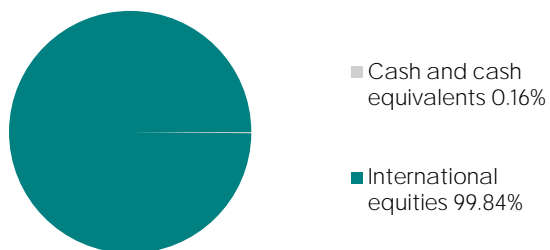
Example of how this applies to an investor

Emma had \$10,000 in the fund on 11 November 2024 and did not make any further contributions. On 31 March 2025, Emma incurred a loss after fund charges were deducted of \$119 (that is -1.19% of her initial \$10,000). This gives Emma a total loss after tax of \$170 for the period.
