
Description of this Fund

GlidePath age 55 is a representation of the GlidePath life cycle. This investment option invests 11% in the Growth Fund and 89% in the Balanced Fund.

What are the risks of investing?

Risk indicator for GlidePath Age 55:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$668 (that is 6.68% of her initial \$10,000). This gives Jen a total return after tax of \$668 for the year.

This shows the types of assets that the fund invests in.


