## Castle Point Funds – Castle Point Trans-Tasman Fund

This fund update was first made publicly available on 13 February 2024.

### What is the purpose of this update?

This document tells you how Castle Point Trans-Tasman Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Castle Point Funds Management Limited prepared this update in accordance with the [Financial Markets Conduct Act 2013](#). This information is not audited and may be updated.

### Description of this fund

The Fund invests in New Zealand and Australian Listed Companies and is benchmarked to the S&P/NZX 50 Index (incl Imputation Credits).

The performance objective of the Fund is to outperform the benchmark over rolling five-year periods after all fees (and other expenses) but before tax.

### What are the risks of investing?

Risk indicator for Castle Point Trans-Tasman Fund

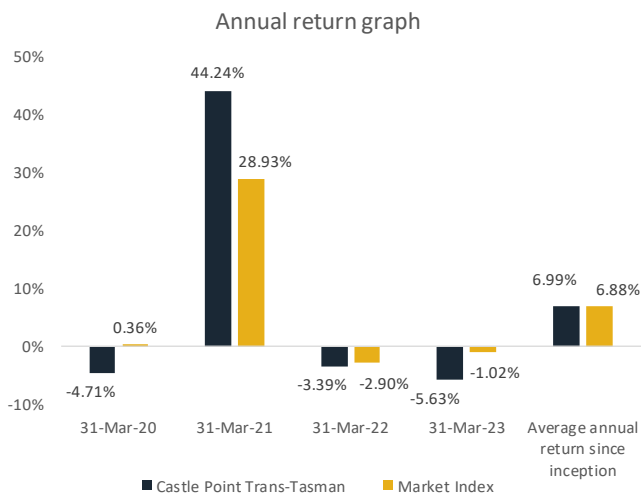

## Example of how this applies to an investor

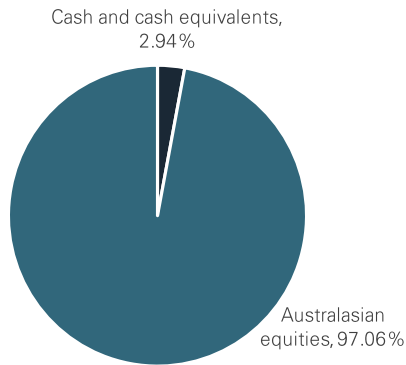
James had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, James received a return after fund charges but before taxes were deducted of \$214 (that is 2.14% of his initial \$10,000). This gives James a total gain after tax of \$133 for the period.



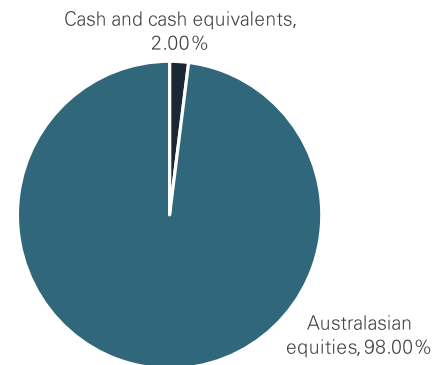

The top 10 investments make up 66.29% of the net asset value of the fund.

The target hedging level as at 31 December 2023 for Australian assets was 95%. The Fund's exposure to assets denominated in foreign currencies was 10.54%, of which 94.05% was hedged. This means the Fund's total unhedged foreign currency exposure was 0.63% of the net asset value of the Fund.
