1. Market Indices, Benchmarks and Investment Objectives

The indices, benchmarks and investment objectives described in this OMI relate to the funds available in the Amova Investment Scheme.

Market Indices

Diversified Funds

For the Amova Conservative, Balanced and Growth Funds (together, "Diversified Funds"), a composite index is used in order to calculate the market index annual return published in each fund's fund update. These Diversified Funds are made up of assets, being underlying sector funds, with an appropriate market index. Amova NZ (the "Manager") believes the use of a composite benchmark for these funds is useful to investors in assessing the performance of each Diversified Fund. The composite market index for each Diversified Fund is made up of the index of the underlying sector funds (where an appropriate market index or peer group index has been identified) multiplied by each respective target investment mix for the underlying sector fund. The average weighted composite return is then applied to the whole fund.
