What is the purpose of this update?


Description of this fund

Invests mostly in defensive assets such as fixed interest, with only limited investment in growth assets such as shares. May be suitable for investors who want to achieve slightly higher returns than those expected from investing solely in the Cash fund. Investors need to be comfortable with the possibility of some fluctuations in returns. This fund is managed with reference to environmental, social and governance (ESG) factors and is certified by the Responsible Investment Association of Australasia.

What are the risks of investing?

Risk indicator for the Sustainable Conservative fund: †



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$622.00 (that is 6.22% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$622.00 for the year.



What does the fund invest in?


Actual investment mix

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for global shares is managed between 0% and 100% on a net of tax basis and may change over time depending on Mercer's view of the relative strength (or weakness) of the New Zealand dollar. Other global asset classes (Global Fixed Interest) target a 100% net of tax hedge to the New Zealand dollar. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 31 December 2024 was 84.38%.
