What is the purpose of this update?

This document tells you how the Kernel S&P Global Dividend Aristocrats Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel S&P Global Dividend Aristocrats Fund invests in globally listed multi-national, blue-chip companies and is designed to track the S&P Global Dividend Aristocrats Quality Income DM ex KR Index (NZD).

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 


Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2024 and did not make any further contributions. On 31 March 2025, Emma received a return after fund charges were deducted of \$1,778 (that is 17.78% of her initial \$10,000). This gives Emma a total return after tax of \$1,631 for the period.
