
Description of this fund

What are the risks of investing?

Risk indicator for the Balanced Fund:



How has the fund performed?

What fees are investors charged?

Investors in the Balanced Fund are charged fund charges. In the year to 31 March 2025 these were:

The Manager's basic fee is disclosed on a before tax basis. GST has been added to the other management and administration charges (estimate) where applicable.

Small differences in fees and charges can have a big impact on your investment over the long term.



Example of how this applies to an investor

Alice had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Alice received a return after fund charges were deducted of \$643 (that is 6.43% of her initial \$10,000). This gives Alice a total return after tax of \$643 for the year.


