What is the purpose of this update?

This document tells you how the World Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ASB Group Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

To provide exposure to a portfolio of international equities. The number of years with negative returns are expected to be greater than for funds in the ASB Investment Funds which predominantly invest in income assets. The World Shares Fund invests in a target investment mix of 100% growth assets.

What are the risks of investing?

Risk indicator for World Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

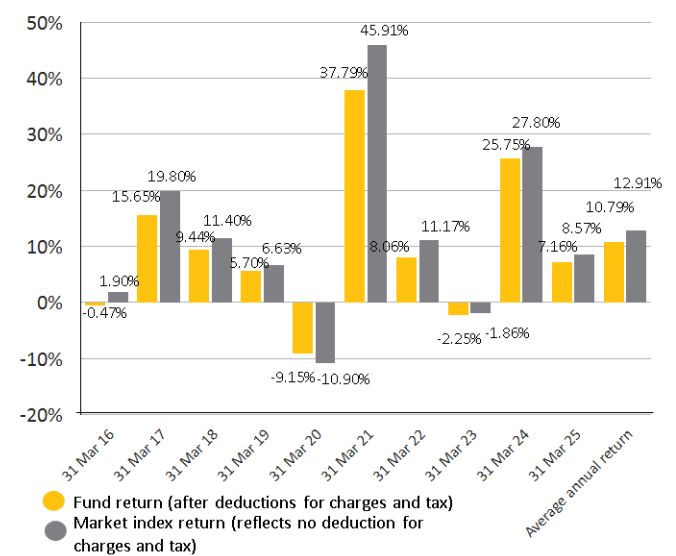

Small differences in fees and charges can have a big impact on your investment over the long term.

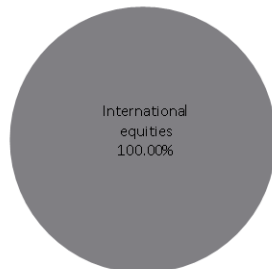
Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$1,227.00 (that is 12.27% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$1,227.00 for the year.

Currency hedging

As at 31 December 2025 the fund's exposure to assets denominated in foreign currencies was 97%, of which 50% was hedged. This means the fund's unhedged foreign currency exposure was 48% of the net asset value of the fund.
