1 / What is the purpose of this update?

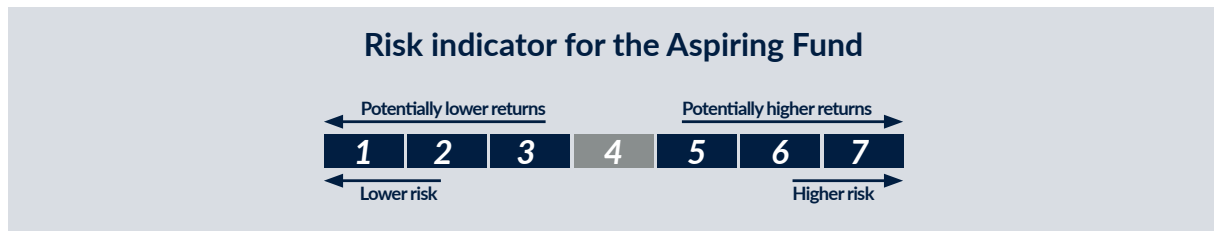
This document tells you how the Aspiring Fund has performed and what fees were charged. The document will help you to compare the Fund with other Funds. Aspiring Asset Management Limited ("Manager") prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2 / Description of this Fund

The Aspiring Fund principally invests in Australasian and globally listed equities, although it may invest in any asset class (including investments in unlisted entities, underwriting arrangements, debt securities, and property). The principal objective of the Fund is to achieve positive absolute returns averaging at least 4% over inflation (after fees and expenses but before tax) over the long term.

3 / What are the risks of investing?



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

4 / How has the Fund performed?

The blended market index returns provided are based on the market indices (All Ordinaries Accumulation index in NZ\$ and the NZ50 Gross index) for the 2 markets in which the majority of the Fund has historically invested. The blended index returns are calculated by taking the average weighting of the Fund's equity exposure to both the New Zealand and Australian markets, and applying this to the returns of the All Ordinaries Accumulation index in NZ\$ and the NZ50 Gross index.

The above graph shows the return after Fund charges and tax for each year ending 31 March for the last 10 complete disclosure years. The last bar shows the average annual return for the last 10 years, up to 31 March 2026.

5 / What fees are investors charged?

Investors in the Aspiring Fund are charged Fund charges. In the year to 31 March 2026 these were:

(D) Manager's basic fee	1.02%
(E) Other management and administration charges	0.19%

6 / Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

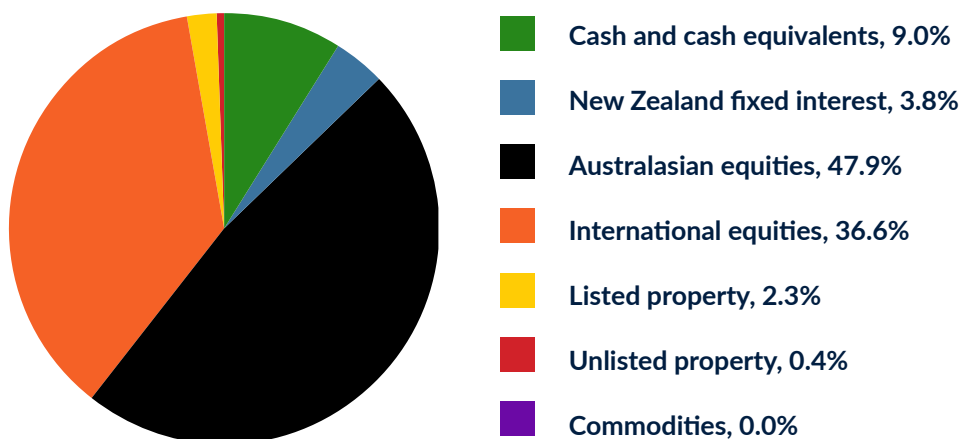
Sam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sam received a return after fund charges were deducted of \$630 (that is 6.30% of his initial \$10,000). Sam paid no other charges. This gives Sam a total return after tax of \$611 for the year.

Currency Hedging

At 31 March, the Fund had hedged 56% of its foreign cash and equities exposure. The Fund has a broad mandate which allows the Manager to choose whether hedging is appropriate and at what level, based on its view on currency value and risk management.
